The goal **#17 of the 2030 Agenda** is about sustainable development for “People, Planet, Prosperity, Peace and Partnership”. **Multi-Stakeholder Partnerships (MSP)** are mentioned as a key instrument in the [Charter of the Future: ONE WORLD – Our Responsibility](#), initiated by Federal Minister Dr. Gerd Müller. The BMZ supports projects and programmes that are in line with the development policy objectives of the Federal Government and the international human rights conventions. The new funding guidelines for the title of “Private Träger” have enabled the promotion of civil society contributions in MSP* since the beginning of 2016.

*Referred to as Multi-Actor-Partnerships (MAPs) in the German context.
